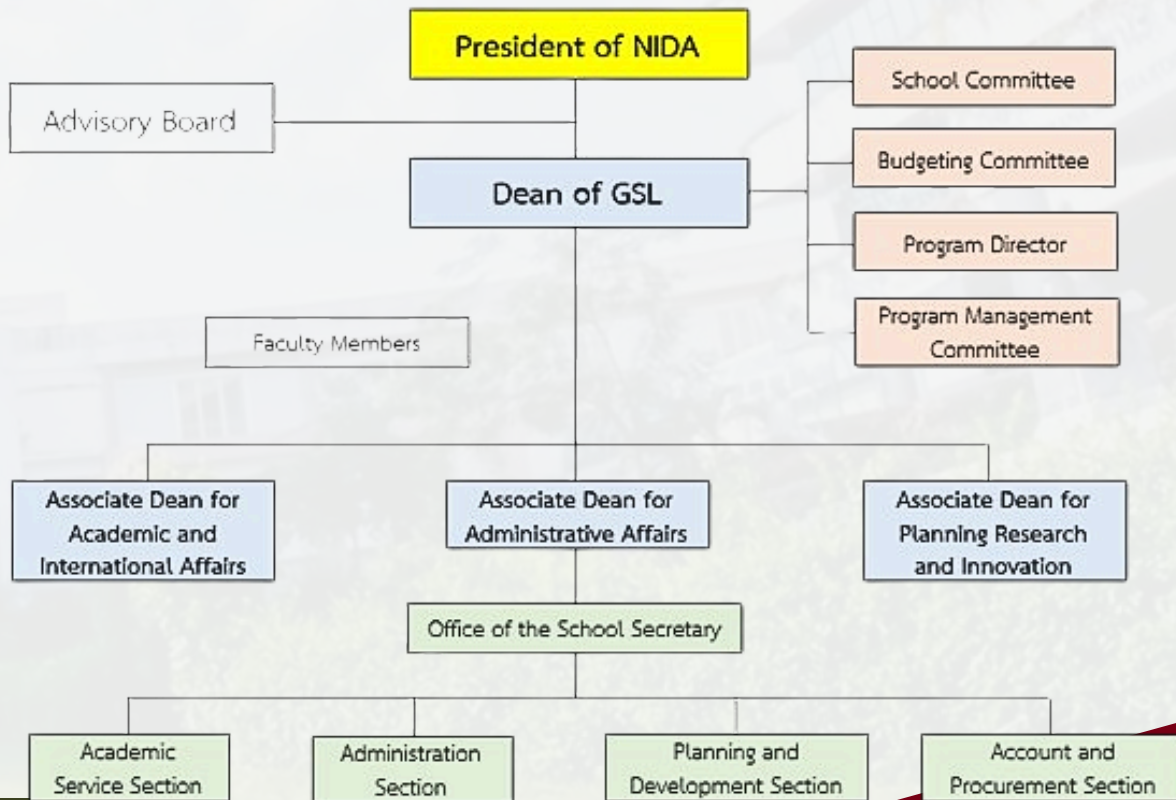
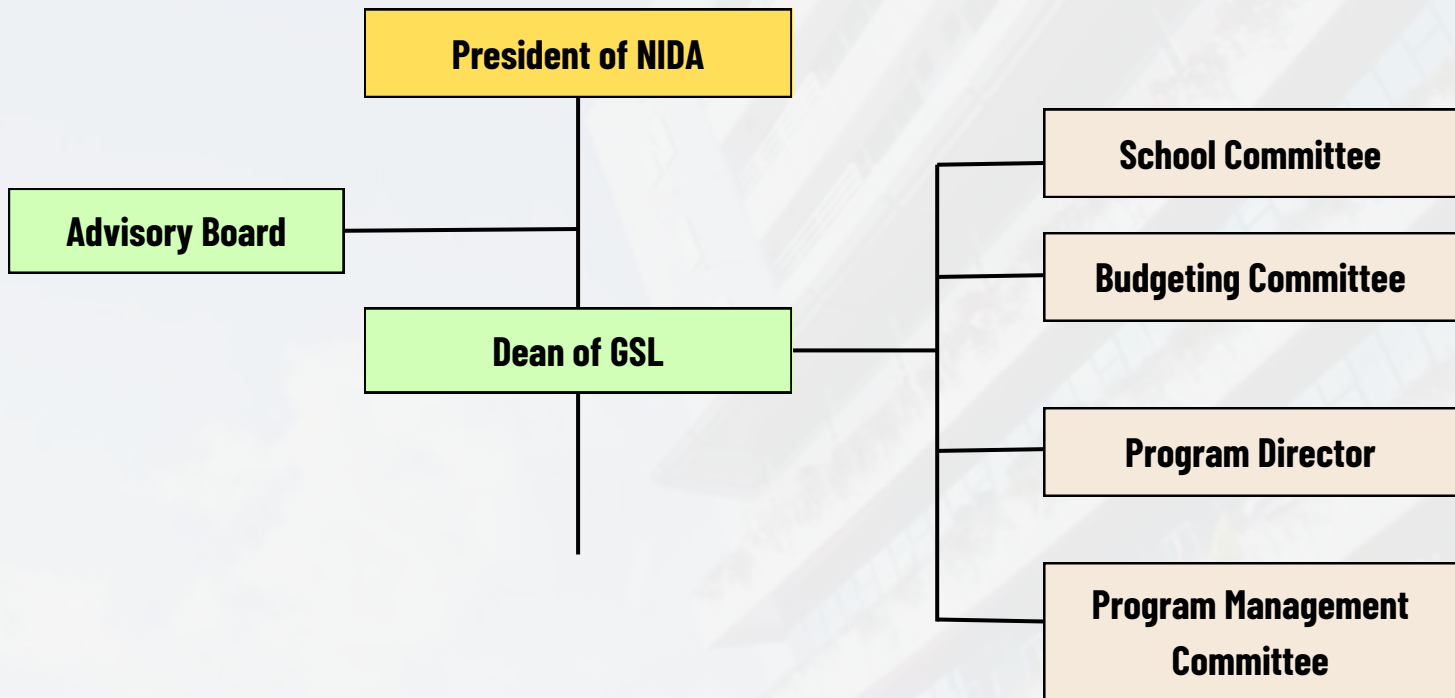

Introducing Our Four Graduate Programs



Doctor of Laws (LL.D.)

- The course is certified and accredited by the Judicial Commission and the State Attorney Commission
- We offer two tracks: 1) Dissertation Track and 2) Coursework and Dissertation Track.
- Classes are held on Saturdays and Sundays.

Program Management System

The program is based on a full-time bi-semester system. One academic year has two semesters, each lasting 15 weeks at the minimum. With the approval of the program management committee, the program might cover a summer semester whose period and credits may be comparable to those in any regular semester.

Course Structure

This course consists of 6 subject groups. It is divided into the theory-based sessions of 294 hours and the practice-based sessions of 33 hours, totaling 327 hours as follows:

Subject Group 1 Basic Principles of Public Law	36	hours
Subject Group 2 General Administrative Law	138	hours
Subject Group 3 Law on the Organization of State Administration	15	hours
Subject Group 4 Law on Administrative Court Procedure	63	hours
Subject Group 5 Specific Administrative Cases	42	hours
Subject Group 6 Practice-based Training	33	hours

The applicants without a law degree or an equivalent degree in law are required to attend additional 30-hour training sessions before starting the course. In this case the total duration is 357 hours.

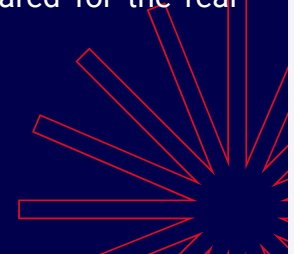


Specialized and highly qualified faculty from a variety of disciplines
